Indicative syllabus	 The module comprises: Introduction to evangelical approaches to interpreting Scripture, including biblical exegesis; Overview of the main biblical genres and specific interpretive features associated with them, with a focus on narrative and epistle; Overview of the biblical timeline and geography; Overview of the historical, cultural and social setting of the Bible through the lens of archaeological finds, historical records, as well as documents and artefacts which illuminate social and cultural values and practices; Introduction to the tools available to assist biblical studies, such as lexicons, concordances and Bible software; Exploration of the cultural and religious background to the life and ministry of Jesus and Paul; Study of the Synoptic Gospels, including an assessment of the synoptic problem, an introduction to the distinctives of each Gospel, and a study of their key themes; Critical discussion of a particular Pauline epistle.
