Brief description	This module develops students' understanding of and engagement in biblical interpretation, with a focus on equipping students to identify and engage critically with key themes within individual biblical texts, such as Romans and Hebrews, and groups of biblical texts, such as the Pentateuch and wisdom literature. The module also enables students to demonstrate critical awareness of approaches used to relate texts studied to contemporary contexts.

Indicative syllabus	<p>The module comprises:</p> <ul style="list-style-type: none"> • exploration of the narrative of the Pentateuch and narrative typology; • overview and critique of documentary hypothesis; • engagement with approaches to interpreting and applying the Mosaic law today; • examination of literary features and theological themes within wisdom genre, with a particular focus on Job, Ecclesiastes and Proverbs; • assessment of key themes and issues within a Pauline text, such as Romans, and non-Pauline text, such as Hebrews (texts already studied at Level 4 should not be repeated).
