Payment of Fees and Charges:

- 1 Where a student withdraws or suspends study from a course during the year, Tuition Fees and Maintenance Charges will be charged according to the College's enrolment and registration policy.
- 2 Tuition Fees and Maintenance Charges can be paid in full at the start of the academic year and a discount of 0.5% will be given if paid by 20 October (the discount does not apply to Student Loan payments or one-off charges). Alternatively, payment of Tuition Fees and Maintenance Charges can be spread over 3 equal instalments, to be paid by 20 October, 20 January and 30 April, unless otherwise agreed.
- 3 Any part-payment of instalments will be used first to clear Maintenance Charges and then Tuition Fees. Unpaid fees will be dealt with according to the student fee debt collection process. Failure to keep up with the schedule of payments may lead to a suspension of enrolment from studies after 90 days, in line with the College's enrolment and registration policy.
- 4 Amounts shown are applicable only for the current academic year and are likely to rise, normally in line with inflation, in future years.

Notes:

- a Residential Maintenance Charges cover the term-time provision of a furnished room, meals on a full-board basis, use of the College laundry facilities, light and heat. Types of room are subject to availability.
- b Non-resident Maintenance Charges cover meals and hot drinks. Lunch is provided for Campus-Based students 3 days per week during term-time (excludes Reading Weeks). All students can book into extra meals in advance via the College Reception.
- c Maintenance Charges for Foundation Year students cover term-time provision of lunch on three days per week and, if required and subject to availability, residential accommodation for two (or three) nights per week with evening meal and breakfast. Subject to availability and placement circumstances, Foundation Year students may be able to apply for full term-time accommodation (as in note a above).
- d This is the maximum charge; an application for RPL which is not complex may be discounted by 50%.
- e Annual subscription to the DBS Update Service is also required (£16 in 2024/25 but subject to change). The DBS check charge is reduced to £50 where the student already subscribes to the update service, and a full DBS check is not required.
- f If change of mode is agreed before 31 May in the prior academic year, this will be discounted by 50%.
- g The annual levy amount is set by the Student Union's Community Council and collected on their behalf by the College. As a guide, the amount in 2024/25 was £50 for Campus-Based students.
- h Where a student is studying a reduced number of modules, an annual charge is made as an addition to the pro-rata tuition fee for the modules studied.
- i Where a student trails a 30-credit module from the previous level, into the next level a charge is made. When this charge applies there is no additional tuition fee for the trailed module.
